

FURTHER AMENDMENT TO ASC NOTICE 3

On June 9, 1999 the Commission recognized the Alberta, Montreal, Toronto and Vancouver exchanges for the purposes of section 107(l)(m)(ii) of the Act. Accordingly, Notice 3, as amended and replaced November 12, 1997, is amended as follows:
