# ASC Staff Notice <br> Numbering Changes to Securities Act <br> Come into Effect January 1, 2002 

## Implementation of Revised Statutes of Alberta 2000

The Revised Statutes of Alberta 2000 (RSA 2000) will be proclaimed into effect on January 1, 2002. This new revision

- officially consolidates the statutes contained in the Revised Statutes of Alberta 1980 or enacted between January 1, 1981 and December 31, 2000,
- renumbers most Acts,
- introduces gender-neutral terminology,
- corrects outdated references.


## Impact on Securities Act

As of January 1, 2002, the current version of the Securities Act will be repealed and replaced. The revised version of the Securities Act has been given a new chapter number (ie. RSA 200, c.S-4) and most of its provisions have been renumbered.

We are attaching a table of concordance relating to the provisions of the Securities Act as they existed on December 31, 2000 to the corresponding provisions in the Securities Act, RSA 2000. This table of concordance is intended as a guide to assist the user in relating the statutory provisions of the Securities Act as they existed on December 31, 2000 to the corresponding provisions in the revised Securities Act contained in the Revised Statutes 2000.

## Updating Commission Rules, Policies, Notices, Blanket Orders and Other Instruments

Commission staff are in the process of updating ASC rules, policies, notices, blanket orders and other instruments to reflect the revised numbering of Securities Act provisions. This updating process will take some time to complete. In the interim, references to outdated section numbers should be read as referring to the renumbered provisions of the Securities Act, RSA 2000.

## Use of Revised Numbering In Material Filed or Deposited With the Commission

All documents required to be filed or deposited with the Commission on or after January 1, 2002 should contain updated references to provisions of the Securities Act, RSA 2000.

## Table of Concordance

All the Public Acts forming the Revised Statutes of Alberta 2000, including the Securities Act, have been given new chapter numbers and most provisions have been renumbered. This Table is intended only as a guide to assist the user in relating the statutory provisions of the Securities Act as they existed on December 31, 2000 to the corresponding provisions in the Securities Act, RSA 2000.

The left-hand column shows the Securities Act as of December 31, 2000 and the centre column shows the revised Securities Act included in the Revised Statutes of Alberta 2000. The "Remarks" column indicates whether certain provisions were repealed by the revision (Rep. by Revision) or omitted from the revision but not repealed (OBNR).
